Whereas the Sugar Island Township Board of Trustees conducts Regular Monthly Township Meetings at the Sugar Island Community Center, located at 6401 E. 1 ½ Mile Road, Sault Sainte Marie, Michigan at 7:00pm, local time;

Whereas the Sugar Island Township Board of Trustees reserves the right to cancel or reschedule regular meeting dates, times or locations, and to schedule special meetings in accordance with statute and policy, whenever the need arises.
